SCHEDULE A to Attestation

1. Exceptions to the completion and accuracy of reports required in section 6 of the BPSAA on the use of consultants;

A non-competitively procurement was initiated for an independent firm to perform a non-union compensation review. Rationale for this procurement was to ensure compatibility with a previous compensation review.

2. Exceptions to the Hospital's compliance with the prohibition in section 4 of the BPSAA on engaging lobbyist services using public funds;

No known exceptions.

3. Exceptions to the Hospital's compliance with any applicable expense claims directives issued under section 10 of the BPSAA by the Management Board of Cabinet;

4. Exceptions to the Hospital's compliance with the perquisites directive issued under section 11.1 of the BPSAA by the Management Board of Cabinet; and

5. Exceptions to the Hospital's compliance with the procurement directive issued under section 12 of the BPSAA by the Management Board of Cabinet;

The Hospital initiated an urgent, non-competitive procurement for minor orthopedic trauma instruments to meet the necessary timing for delivery and funding requirements. This strategic single-sourced procurement was made with approval of senior management to maintain operational effectiveness, quality of care, and value for money. It is critical in the healthcare industry that the organization maximizes the value it receives from the use of public funds and that procurement activities result in the delivery of the right product or service at the right time and right place.

The Hospital and/or our Shared Services Organizations (SSO), which include Shared Services West, Mohawk MedBuy, HealthPro, Canadian Medical Equipment Protection Plan, Kinetic GPO and the OECM, continue to execute a sourcing strategy that maximizes available resources to complete procurement requirements in a timely and effective manner. With the exception of the above noted non-compliance, all SSOs have stated they are fully compliant with the BPS Procurement Directive for the 2023/24 fiscal year. The Hospital will continue to oversee its procurement processes to ensure continued alignment with Hospital procurement and signing policies as well as the BPS Procurement Directive, CFTA and CETA requirements.
